#### DIRECTIONS FOR USE

FOR USE ON DIVOT MIX AND TOPDRESSING ONLY.

ENSURE PRODUCT'S UNIFORMITY PRIOR TO USE. SHAKE OR AGITATE IF NECESSARY.

DISPERSE DISPLACE XL THROUGHOUT THE DIVOT MIX OR TOPDRESSING USING A CONCRETE MIXER, FRONT LOADER OR CONVEYER.

### USE RATES

Apply 1 to 2 ounces of REPLACE XL to 100 pounds of sand Apply 1 to 2 pints of REPLACE XL to 1 ton (2,000 pounds) of sand

To lighten color: Add additional sand and mix until desired color is achieved.

To darken color: Add additional REPLACE XL and mix until desired color is achieved.

## STORAGE AND DISPOSAL

May be stored below 32° F if thawed and thoroughly agitated before use. Keep container closed in storage. Do not allow water to be introduced. Store only in original container. Triple rinse when empty and offer for recycling. Always dispose of container in accordance with local, state and/or federal regulations. Do not reuse empty container.
